

DISTRICT COURT BRIEFS

Charged with endangering child

Mansfield resident Dannie Gardner, 42, was arrested on June 15 by Dallas Township patrolman Douglas Higgins after police were called to the Turkey Hill at the intersection of Rt. 415 and Rt. 118. Gardner was sitting on two milk cartons inside the convenience store holding his son. When police arrived he asked them for a doctor and a new camera and told them he did not want the state police to come near him because he believed they put an electronic bug in his son's car. Gardner would shift between a violent and a calm mood. He would hold his son tightly, squeezing him around the neck and then let him go and talk to police in a calm manner, according to police.

Gardner told police that he was in a domestic dispute with his ex-wife, who has custody of their five-year-old son. Information from the Mansfield police department confirmed his story and said they were in the process of obtaining warrants for Gardner.

The defendant resisted arrest and after police applied handcuffs they took him to the Wilkes-Barre General Hospital to be examined. Gardner's son was separately taken to the hospital to be examined.

Gardner was charged with recklessly endangering another person, harrasment, criminal mischief, endangering the welfare of a child, resisting arrest and disorderly conduct.

troldman Martin C. Maransky observed him speeding and driving erratically on Carverton Rd. and Bunker Hill Rd. Mullen drove at high speeds refusing to stop for police signals until his vehicle hit a tree on Bunker Hill Rd. He was taken by ambulance to the Wilkes-Barre General Hospital where his blood alcohol level was found to be .135.

He was charged with driving under the influence of alcohol and fleeing or attempting to elude oficers.

RESISTING ARREST

Edwardsville resident Edward W. Gallagher, 22, was arrested July 29 by Kingston Township patrolman Frank Ziegler after police were called to domestic dispute on Meadowcrest. A background check showed that Gallagher was wanted for not appearing in court.

After the police informed Gallagher of this he ran out the back door of the Meadowcrest residence into the woods. Police caught up with him and stopped him. Gallagher bit one officer's finger and resisted arrest, according to police reports. He continued to bang his head on the plexiglass window inside the car.

He was charged with resisting arrest and simple assault.

Wilkes-Barre resident Richard Anthony White Jr., 20, was arrested on July 4 after Dallas Borough patrolman James Drury observed he was driving a Corvette with expired plates. After calling in the plate number, police were informed that the car was reported stolen three days earlier. The car belonged to a dealership in Lower Merion Township. White told police the car was give to him by a man from Harveys Lake.

He is charged with receiving stolen property, driving without a license and driving an unregistered vehicle.
