State offers forgiveness of agriculture education loans

The Pennsylvania Higher Education Assistance Agency (PHEAA) has recently announced that applications are now available for the Agriculture Education Loan Forgiveness Program, according to Senator Charles Lemmond (R-

Lemmond explained that students who have borrowed money from PHEAA to pursue a degree in agriculture or veterinary medicine may be eligible for a loan forgiveness program established by the Commonwealth. PHEAA established this program to encourage individuals with degrees in agriculture and veterinary science to return to a family farm in Pennsylvania or to devote all or a portion of their veterinary practice to farm animals.

The program will repay up to \$2,000 per year of PHEAA-guaranteed student loans for each year the borrower is employed full-time in agricultural-related field. Borrowers are limited to a lifetime maximum of \$10,000.

Lemmond said to be eligible for the program, a borrower must remain in Pennsylvania after graduation and be employed full time in the operation of a family

farm, a family corporation or practice veterinary medicine. Family farms and farm corporations must also be used for the production of agricultural products for commercial purposes and devote 75 percent or more of its assets to the business of agriculture.

Veterinarians must be certified by the U.S. Department of Agriculture to sign health certificates required for the interstate commerce of agricultural animals and animal products. Veterinarians must also be able to certify regu-

Applicants must have a degree related to agriculture or veterinary medicine from a Pennsylvania school or college. Applicants must also be in their first year of full-time employment in the field on or after July 1, 1991. Only those loans guaranteed by PHEAA
