Marjorie Brown turns grief to action, presses for bus safety

DALLAS - Ever since her son, Mitchell, was killed by a school bus on Oct. 30, 1992, Marjorie Brown has worked non-stop to prevent similar tragic accidents.

Mitchell was hit by a school bus shortly after he got off it near the intersection of Pioneer Ave. and Holcomb Rd. in Shavertown. Brown believes her son's death could have been prevented if the bus had been equipped with a crossing control arm.

Brown has been diligently writing letters to state representatives, schools and organizations for more than five years. Her goal six to eight feet in front of the bus when the bus is stopped. Since children will have to walk around the arm, the bus driver will see them cross and know when it is safe to move the bus forward.


Brown has established contacts with state representatives over the years and they keep her posted on any new developments in legislation concerning bus safety. Recently she was informed that the Senate Transportation Committee unanimously adopted an amendment that authorized school buses to have crossing arms beginning Jan. 1.

The amendment also would mandate that all buses have crossing arms by July 1, 2000. "The state officials are really concerned," said Brown. She mentioned that representatives George C. Hasay and Phyllis Mundy, and senator Charles D. Lemmond, have all made contact with her and showed great interest in this issue.

Brown has been involved with many organizations in the area. She attended Safe Kids of Luzerne County conference last year. "They are a nice group of people. They used grant money on school bus safety," she said.

In 1992, the Dallas School District purchased and installed some crossing arms with grant money. It costs \$210 for one crossing arm, not including installation, 42 buses is equipped with a crossing arm, said Susan Farr, transportation advisor.

Lake-Lehman also holds bus safety lessons for their students at the elementary school level. Some of the district's 42 buses have the crossing arms. They were installed by the contractor




Brown has learned that many people share her concern with bus safety. "Many more people seem to becoming involved," she said.


