Anzalone show with von Trapp Family to air Saturday

Two musical families will take the stage Saturday when WVIA-TV presents "The Anzalone Brothers & Company Special" featuring members of the famed von Trapp family.

Filmed by WVIA at the von Trapp Family Lodge in Stowe, Vermont, the show brings together two families that first met in 1947, when Fr. Samuel Anzalone invited the von Trapps to perform at West Pittston High School. Fr. Anzalone was the uncle of Dr. A. Anthony "Ange" Anzalone of Huntsville and attorney Jim Anzalone, two of three singers in the Anzalone Brothers group. They are joined by Richard Starkey, of Nazareth, on guitar and vocals; Carl Kohl, on banjo, and Ray Cavaliere on bass.

Ange Anzalone said his uncle's church was in California, where he became a friend of Danny Thomas, Lawrence Welk and others. "He was very interested in entertaining," Ange said.

Fr. Anzalone met the von Trapps while he was studying in Canada, before they settled in Vermont in 1942. The family, whose story was told in the musical "The Sound of Music," later made into a movie named Best Picture of 1965, still operates a lodge in Stowe, where filming took place April 3. Ange Anzalone said the production took all day, from 9 a.m. until after 10 p.m., to complete. In addition to musical numbers, the show will feature performances by a group of danc-

direction of Barbara Woronko Anzalone, Ange's wife. "I always wanted to do a show with them," Ange Anzalone said. The program will

appear on WVIA, channel 44, Saturday from 9 to 10 p.m.



Price said Kopcha's request was understandable. "I have no problem with presenting three names, justifying ranks and affording the board the opportunity to look over the candidates before making their decision," he said. "They are asking for choices."

Whipple is vehemently opposed to the idea. "I don't know how they think they could have concrete input into hiring," said Whipple, who has gotten many calls from people concerned about the decision.

"It opens the whole situation up to politics. It doesn't make any sense. I don't think it is our job to question the recommendation of the administration.

Whipple said the district has a good hiring process that "came up with a real good group of people last year." She said calls pour in from people who have someone they want hired. "It's very simple to say, 'I'm not involved."

Rossi also thinks the current hiring process yields great teachers. "I'm happy with the way it is right now. All the teachers who were hired last year got high marks," said Rossi, who voted for the suggestion. "It's fine with me if they want to look into other ways of doing it.'

Price believes if the board were any more involved in the hiring process it would be a contradic-

tion to the checks and balance system. "Having the board interviewing or screening would be a conflict," he said.

Kopcha said many school boards, such as Crestwood's, are more involved in the hiring pro-

In the Dallas School District, at least one representative of the board meets with the top three candidates after the administration has held two previous interviews. Gil Griffiths, superintendent, said any interested board member may sit in on the final interview.

"The board will ask for a recommendation and if they feel that person is the strongest for the position they will hire that person. If the board feels that person is not the strongest one for the job, they have the ultimate say," explained Griffiths, who said the process has been the same for at least 11 years. Griffiths said every district handles the process differently.
