Holding the new Back Mountain Trail Sign, many local public officials helped to open the first mile of a walking and biking path from Luzerne to Wildcat Falls. A new \$250,000 Grant from the Pennsylvania Conservation Corps, partners with the Department of Labor and Industry, PennDOT, and Federal Highway will secure funding to complete Mile 2 to Carverton Road in 1999. Anthracite Scenic Trails Association is a volunteer organization converting the old Lehigh Valley RR bed into the Back Mountain Trail along Route 309 for 15 miles from the Susquehanna River (Kirby Park) to Harveys Lake.
