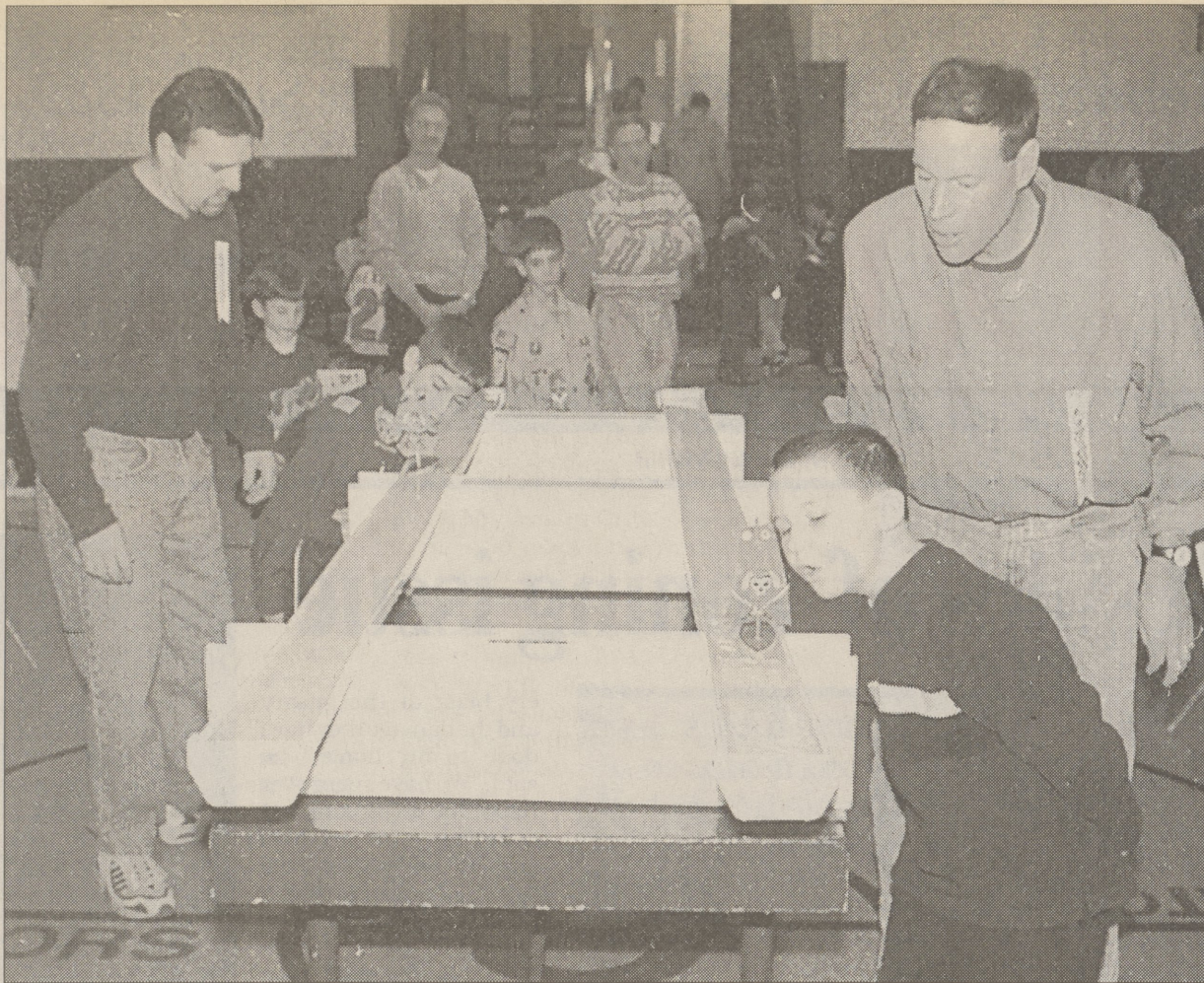


# Scout power
