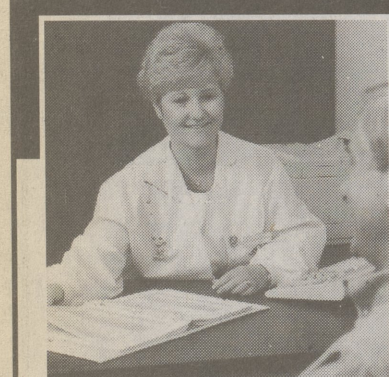
Wilkes University offering new access to local art scene

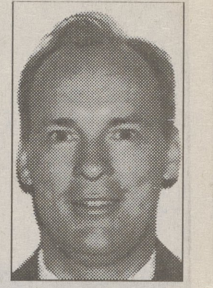
