HARVEYS LAKE - The borough has a new zoning officer and a new way of compensating him.

Milton Lutsey was appointed zoning officer at the June 20 meeting of borough council, with compensation of 80 percent of permits and fines issued. His position will include a six month probationary period. Richard Haas, Chairman of the Ordinance Review Committee was directed to develop a job description for the new zoning officer.

Four sealed bids were opened for the 2000 paving project. Following the engineer's recommendation, American Asphalt Paving of Shavertown was awarded the contract with a low bid under \$60,000 and an alternate bid of \$2,227,50 for the Old Lake Rd.

Correspondence from Pasonick Engineering gave council an estimated figure for the new maintenance building, with revisions, of \$275,000 in building costs and \$20,000 engineering fees. Their fees would include code inspections and other ongoing work during the actual construction.

In reference to the building project, Millie Monk asked if the borough had applied for any grants and how many grant applications were approved for 1999. Councilman Dan Hanson gave a summary of their efforts to date.

Mrs. Monk pointed out that Housing and Urban Development had funds which could have been used for such a project, but "I know that HUD has divided up the money for this year." She suggested that they contact John Matusek in the county office to get applications for the future.

George Andrews, council president explained why the borough hadn't received a grant. "There is no full-time borough administrator to research grants," he said. "Anyone in the community who knows sources, please call us and let us know.

Hanson said Karen Boback had been awarded a \$1,000 scholarship for each of her four years of college. In order to qualify, the student needs a 3.5 grade point average and a letter of acceptance to college. He should be contacted by January of 2001 by anyone interested in earning next year's scholarship.

Lake-Lehman budget

holds line on taxes

□ *Vote is 5-4*. School director points out lack of public hearings.

LEHMAN - The Lake-Lehman board of school directors passed a budget with a no tax increase at the Tuesday, June 20 meeting, but not without opposition. The budget passed 5-4. The motion was read by Angelo DeCesaris and seconded by Lois Kopcha. DeCesaris, Kopcha, Robert Allardyce, and James Kapitula voted against the budget.

"I can tell you right now I'm not voting for this. We're not following procedure," said DeCesaris. DeCesaris pointed out that specific budget hearings were to be held as part of policy, which the board was not following. School district solicitor Peter Savage noted that the public has always had an opportunity to give input on the budget. "Just because we haven't done one (a hearing) in the past doesn't make it right," said DeCesaris.

DeCesaris also wanted to raise the penalty on unpaid taxes higher than the current rate of 10 percent. "We're budgeting a mil as less than what it should be because of delinquent taxes," said DeCesaris. Savage read the law, which states that 10 percent is the maximum penalty. The board also set the date for payment in rebate for September 8, and the last day of payment in face as November 7

The budget listed total expenditures of \$17,847,953, \$10,964,714 of which was budgeted for instruction, and revenues from local state and federal sources of \$17,697,953. Including the unreserved fund balance of \$1,800,000 the total revenues are \$19,497,953. The real estate millage was set at 221 mills for the properties in Luzerne County, and 42 mills for Noxen Township in Wyoming County. School Board business manager Kathleen Williams said that the final fund balance figure would not be known until auditors examined the fig-

The board also saw a presentation from Kurt Rose of PSBA consultants about the board's search for a new superintendent. Rose said PSBA would help the board recruit and advertise for the position opened when Dr. William Price announced his resignation last month. The consultants would help the board formulate search criteria, and would have staff, students, and the public meet with the finalists. Moderno Rossi hoped to find a replacement in four months, but Rose suggested a six month search. If the chosen candidate was employed at a school or university, they could leave gracefully between semesters, he

The board also authorized Williams to request proposals for software that reports and calculates transportation data. Last week the board received a presentation from Advanced Management Systems, a company that sells such software. "A system will give us accurate information for equitable reimbursements, and will accurately map student's whereabouts," said Dr. William Price, the outgoing superinten-

In an executive session, the board interviewed two candidates for interim superintendent, then approved Robert Roberts, principal of the Lake-Lehman Middle Level School. Roberts will earn \$325 per day, and start as superintendent July 1

The next regular meeting for voting purposes will be held on Tuesday, July 11 in the Lake-Lehman high school auditorium
