more work to do on the brief pressing the case of the township vs. American Asphalt mining operations in an agricultural zone. The status of the brief was not announced.

Zoning Officer John Krupa gave an update on citing American Asphalt. "I did cite them for mining in an Agricultural Zone," he said. Krupa explained that anyone cited gets 30 days to rectify the problem, but in this case, they appealed to the township zoning board. The next step would be the Court of Common Pleas, not the Magistrate, as originally thought by the supervisors.

Several questions from the audience went unanswered due to their legal nature and the absence of Solicitor Evans. This case will be presented at the upcoming October 12 zoning board meeting. Ed Chesnovitch expressed concern that the township would need to be represented by Evans or someone with expertise in these specific cases at the hearing. It was pointed out that Attorney Geddes is the solicitor for the zoning board, so Evans might have little or no input at that meeting.

Gerry Olenik of the Department of Environmental Protection gave an update on the status of the gasoline spill cleanup. Soil removal has been completed and shipped off site by Sun Pipeline Co. "We've been sampling (water), they (Sun) have been sampling, levels have dropped," he said. "The plume has dropped and things are stabilized," he added Chesnovitch asked if DEP is looking for other potential sources such as a local gas station which he attributed to statements made by DEP spokesman Mark Carmon. Olenik said other sources are possible and would be investigated.
