Says Kingston Twp. was wrong to cut trees

Township, PA:

Let it be known that from November 3-5, 2000 on the watch of the current Kingston Township Board of Supervisors, a 105 yearold Pennsylvania white ash tree was removed from the enbankment above the old Township building at Carverton Road. This tree had no internal blemishes.

This clearcut by "TP Tree Service" under contract by Kingston Township, netted at least two full logging trucks of prime, hardwood timber.

According to an interview with Mr. Jeffrey K. Box, Townsghip Manager, on November 3, 2000, most of the trees designated for removal were dead or dying. This is false. The photoraphic record and inspection show that with a few exceptions, the trees were

ONLY

To the Citizens of Kingston healthy and posed no public safety erosion management regulations; hazard.

In the name of public safety, Kingston Township has clearcut the trees on a steep enbankment. This critically destabilizes the slope above the building, threatening the parking lot below and the newly opened Anthracite Scenic Trail at the crest of the embankment. Erosion, if unchecked, from this site will degrade the water quality of Toby's Creek, and ultimately the Chesapeake Bay.

The unilateral action by Kingston Township supervisors to cut these trees represents:

(1) a failure by the township to work in partnership with community environmental leaders;

(2) an illegal "takings" of a community resource without due consideration and process;

(3) ignorance of the Chesapeake Bay compact and Luzerne County

(4) flagrant disregard of Article 1, Section 27, of the Pennsylvania Constitution:

The people have the right to clean air, pure water, and the preservation of natural, scenic historic, and esthetic values of the environment. Pennsylvania's public natural resources are the common property of all the people, including generations yet to come. As trustees of these resources. the Commonwealth shall conserve and maintain them for the benefit of all people.

I call upon all citizens of Kingston Township to protest this clearcut and to demand complete ecological and engineering restoration of the damaged site


30 Years Ago - Nov. 5, 1970 LIBRARY TAX LOSES BIG

70 Years Ago - Nov. 7, 1930 LAKETON STUDENTS WIN **VOCATIONAL PRIZE**


