Huntsville Christian Church hosts Operation Christmas Child

 Since 1993, this project of Samaritan's Purse, an international Christian relief organization, has collected and distributed millions of boxes to needy children around the world.

 "We wish to thank Bullock's Tire and Auto Store for donating a U-Haul trailer for us to use to deliver the boxes to Lewisburg," said Mrs. Kutz. "And we want to thank everyone who donated the boxes to help children around the world who will now enjoy a little of the spirit of Christmas."
