therefore, reduce the ultimate Inheritance or Estate Tax bill, while preserving the property owner, because forever, land of natural scenic beauty.

A land trust will investigate the land, take an inventory of "natural" characteristics and qualities of such land, and then accept the easement as the owner of the same, for the benefit of all through permanent conservation and protection of the natural environment. An appraisal contracted for by the landowner will show what the worth of the gift (e.g. Easement) is for income tax deduction purposes as well as the reduced value of the remaining property interest retained by the property owner. The Conservation Easement takes the form of a deed from the property owner, which is recorded at the Courthouse. The deed restricts future development of the property and when the property is transferred, the restriction "runs with the land" to future owners of the real estate.

The landowner can still

use the land and basically

keep it the way it has always been enjoyed. Upon death of valuable development rights have now been removed and the commercial value diminished, the surviving family members will pay less Inheritance and Estate Tax upon

the land. What an exciting proposition! A conservation tool which is both "green" in the natural sense and which saves "green" (cash) at the same time.
