DRUG CHARGES AGAINST PRISON VISITOR

Fatima Evette Baker, 32, of 429 East 25th Street, Erie, pled guilty to a single count of possession of marijuana at a preliminary hearing in front of District Justice James Tupper.

According to arrest papers, Correction's Officer Michael Prushinski found an unknown amount of marijuana and a Philly Blunt cigar in a purse in the trunk of Baker's car during a routine investigation in the State Correctional Institute -Dallas visitors' parking lot.

Baker was fined \$193, and an additional count of possession of a controlled substance was dismissed.

BAD CHECKS

John Robert Phillips, 44, of RR 1 Box 154 Noxen Road, Harveys Lake, waived his right to a preliminary hearing in front of District Justice James Tupper on 18 charges of writing bad checks at BiLo Markets, Country Club Shopping Center, totalling \$949.65.

According to arrest papers, Phillips wrote the checks from February 25 through March 17 at the supermarket on an account which had insufficient funds.

Jamie Okane, 19, of 266 Grove Street, Pringle, pled guilty to two charges of writing bad checks, totalling \$201.12 at BiLo Markets, Country Club Shopping Center, Dallas, in front of District Justice James Tupper.

According to arrest papers, Okane wrote the checks on a closed account.

Laura Edson, 37, of 226 E. Grand Street, Nanticoke, waived her right to a preliminary hearing in front of District Justice James Tupper on a single charge of theft by deception.

According to arrest papers, Edson falsely reported a claim to Erie Insurance Company, Bethlehem, Pa. reporting she injured her hand in a car door, and received treatment for the injury, including x-rays at a Wyoming Valley Health Care facility.

Police said Karen Schydlowski, 116 Tunkhannock Highway, Dallas told an investigator for the insurance company that Edson injured her hand in a wooden door while in a heated argument with her son at Schydlowski's home.

Edson later admitted to police she did in fact injure her hand at Schydlowski's home, and that Schydlowski, her girlfriend whom she had lived with at the time, did not want a claim filed on her homeowner's insurance, so Edson filed it on her own automotive policy. She also said she and Schydlowski later parted ways and Schydlowski turned her in.

CHARGES FILED IN CASE OF MISSING TEENAGER

Joshua J. Egelund, 23, of 847 County Highway C, Washburn, WI, had felony charges of concealment of the whereabouts of a child and criminal use of a communications facility held over to county court after a preliminary hearing with District Justice James Tupper.

Egelund was charged in connection with a March 21 incident in which Lauren Nafus, 16, of Dallas met Egelund on the internet and traveled with him to his home in Wisconson without the prior knowledge or consent of her parents.

Police had been searching for a small light blue or gray car with Washington license plates, which later turned out to be Egelund's, according to a March 28 article in The Dallas Post.

According to police, Nafus was located after she contacted her parents from Wisconson to let them know she was safe.

Egelund is currently housed had a handgun. in the Luzerne County Correctional Facility.

FORGERY, DRUG CHARGES

Kimberly Branas, 29, of RR 1 Box 187 E-1, Sugar Run, Pa., waived her right to a preliminary hearing in front of District Justice James Tupper on two charges of forgery, attempting to obtain a controlled substance, receiving stolen property and a felony charge of obtaining a controlled substance.

According to arrest papers: Branas attempting to pass a forged prescription at Rite Aid Pharmacy in the Dallas Village Shopping Center, Dallas for Stadol NS #2, a controlled substance usually used to treat mi-

graine headache pain. Police said when pharmacist Vera Williams contacted Dr. Mark Polin, whose name was on the prescription, an employee there told Williams Dr. Polin never prescribed the drug and that Branas had stolen a prescription pad from his office two weeks earlier

Police said shortly after being released from police custody, Branas returned to Rite Aid and again tried to have the prescrip-

Police said pharmacist John Zierowicz notified the police of Branas' actions.

ROBBERY ATTEMPT MADE AT **GRAVE SITE**


