Employees claim after they went out and obtained new positions, they were not notified they would not receive severance pay until just prior to, or after their scheduled end dates of separation

"Some went out and found jobs based on what they were told," said Michael Kurtinitis, a whether they were paid severmaintenance mechanic who is now working on the production line to fulfill orders.

"And two days before they were to leave, they were told they wouldn't get severance," said Lambert.

Sam Perry, former controller for ENCON who had been with the company for 10 years, says he is one of three employees who pursued new employment and lost their severance pay as a result

Perry, who was unwilling to be interviewed for this article, said in a statement that he is pursuing legal action.

In the statement Perry said he volunteered to leave February 15, the first day of scheduled

ance during the prior reductions in force that were made by EN-CON," said Perry in his statement.

John Ray, ENCON General Manager, said although employees were told layoffs might start February 15, he said the date was never definite. Instead, he said, the date was given so employees would know their jobs would be secure for the 60 days following the closure announcement.

"The date of February 15 had nothing to do with severance," said Ray. "Back in December we had to pick a date of when we thought we might have reductions."

Ray said in the meantime cus-

did not occur, the employees were not actually volunteering to be laid off. They were voluntarily resigning, which is not covered by the severance pay plan.

Ray said previous layoffs had been accompanied by severance because employees were discharged for a lack of work.

He said with the recent increase of customer orders, a "lack of work" situation never resulted.

"We still have requirements for people's skills and qualities to meet our customers' needs," said Ray.

He said employees who stay until the closing date will receive severance.

Ray said in Perry's case, he should have known the policy better than anybody, since he was a senior executive and worked in the office.

He said following the employees' loss of severance, there was confusion in the plant about the policy. He said he then sent out an employee notice, dated February 13, explaining the situation. He said since then, the confusion has been cleared up.




