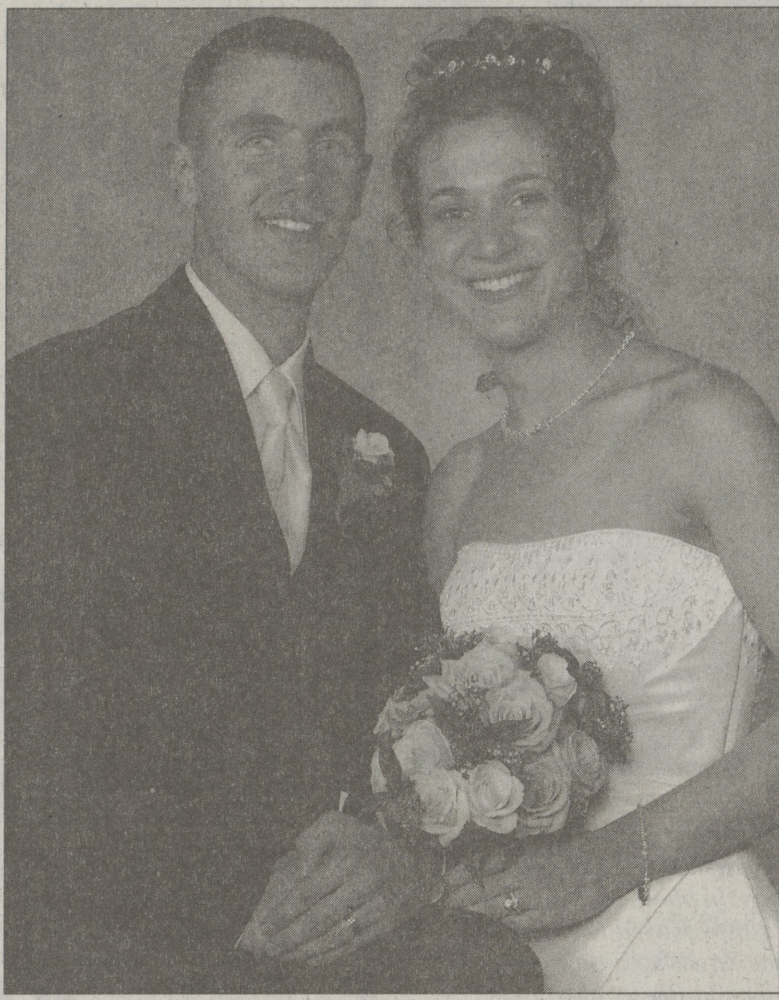

Francis J. Collini, M.D., F.A.C.S., P.C. is among a group

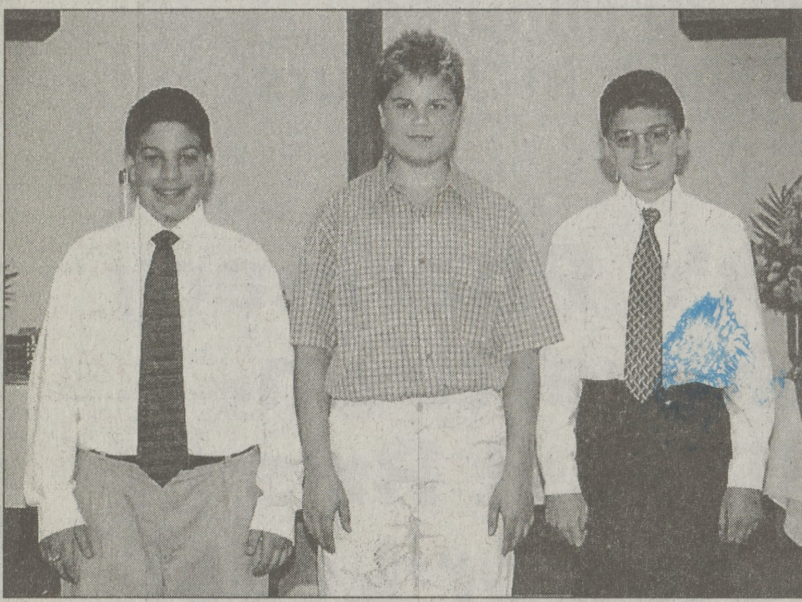


