Civility and ethical leadership topic of September Ethics Institute presentation

Civility and ethical leadership in business and the world at large is the topic of presentations by noted ethicist Edward S. Petry, Ph.D. during a dinner and public forum to be held on Wednesday, September 17 at the Sheehy-Farmer Campus Center on the King's College campus in Wilkes-Barre. The event is sponsored by The Ethics Institute of Northeast Pennsylvania at College Misericordia. Dr. Petry's lecture, "The Call to Civility and Ethical Leadership," will be presented to community leaders during a closed program from 5:15 p.m. to 7:30 p.m. A second forum will be held and is open to the general public beginning at 7:30 p.m.

Dr. Petry is the executive director and a member of the board of directors of the Ethics Officer Association (EOA). Since 1995 when Dr. Petry assumed the EOA's top executive position, membership in the association has grown by more than 500 percent to nearly 900

members, and includes more than 50 percent of the Fortune 100 as well as other notable organizations, including the New York Stock Exchange, the American Cancer Society and the City of New York.

At the EOA, Dr. Petry has overseen the development of what are recognized as the premier conferences and training programs in the business ethics field. He has developed partnerships between the EO and the World Bank and the U.S. Sentencing Commission and is now leading an effort to create a Global Business Conduct Standard.

Dr. Petry has edited and/or co-authored six books on business ethics, including *The Ethical Edge: Tales of Organizations That Have Faced Moral Crises* (1996); and *The Ethics of Accounting and Finance* (1996). He has authored several major business surveys, articles on business ethics and has been a featured speaker at numerous national and interna-

tional forums. He has been quoted or appeared on the topic of corporate ethics and compliance in journals, newspapers and media outlets, including CNN, The Wall Street Journal, USA Today, FOX News, The Today Show, The New York Times, The Financial Times and many others.

He received his Ph.D. in philosophy from The Pennsylvania State University and has degrees from The University of Toronto and Trinity College. Dr. Petry, his wife, and three sons reside in Worcester, Mass.

Dr. Petry's theme will continue at the Ethics Institute's annual Ethics Day dinner, scheduled for October 23 at the Woodlands Inn and Resort. The guest speaker and honoree at the dinner will be Rev. Thomas J. O'Hara, CSC, president of King's College.

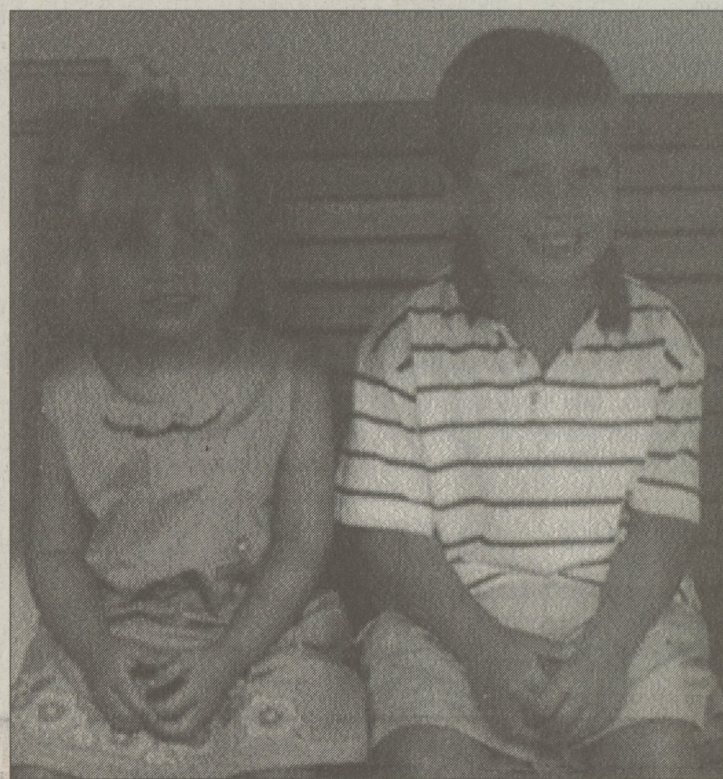
