College Misericordia opens new bell tower

College Misericordia recently opened the Geraldine Ruth Daley Anderson Bell Tower, the newest addition to the renovated Mercy Hall, formerly the Administration Building. The entrance at its base creates a new entrance to Mercy Hall.

Named in memory of Geraldine Ruth Daley Anderson, a noted educator and education supporter in the Wyoming Valley, the bell tower was a gift of her husband, Dr. Robert S. Anderson.

The tower was designed by Quad Three Group, Inc. The ntractor was Sordoni Conruction Services, Inc., Forty Fort.

Constructed of brick and pre-cast concrete, the tower is 75 feet tall. The new carillon system produces the sounds of up to eight different bells.

The college's Anderson Sports and Health Center as well as the Anderson Athletic Fields are named after the couple. The college also annually awards the Geraldine Ruth Daley Anderson Scholarship to female Coughlin High School students who meet the college's academic requirements and who have demonstrated academic excellence and leadership skills in school.

LEHMAN TWP. — During Tuesday's School Board work session, Bill Jones of Volunteers of America asked the board to consider the possibility of turning the former Lake-Lehman Middle School into subsidized housing for the elderly.


