# **Trail garners** key easements

Section 2 of the trail, from Trucksville to Dallas, is now in planning stages.

Organizers of the Back Mountain Trail have taken a giant step toward its completion with the acquisition of easements that will release a flood of funding.

The new easements secure the right-of-way from Carverton Road in Trucksville to Lower Demunds Road in Dallas Township.

"We've been actively trying to complete section two of the trail for five years," said Judy Rimple, president of the nonprofit Anthracite Scenic Trails Association, parent to the Back Mountain Trail Association. "Now we can secure a grant from the Department of Conservation and Natural Resources (DCNR) for preconstruction drawings. As soon as we get the drawings, we'll have met all of the requirements to go to construction."

At that point, the Back Mountain Trail will receive grant monies from the Transportation Enhancement Act (TEA 21) amounting to \$480,000. The association was also required to match 20 percent of the grant, which it did during the past few years. "We used lots of little grants and

## wimming meet pits coach against former pupil

Matt Stretanski, Dallas coach, once swam on a team coached by Lake-Lehman mentor.

DALLAS TWP. - What goes around, comes around, even in the water.

The Lake-Lehman High School swiming team had its inaugural meet Dec. 6 ainst Dallas, an event that pitted Dallas coach Matt Stretanski against his former mentor, Maureen Judge Devine.

"She was my first or second coach," Stretanski said. "I was on her swim team when I was 7, 8 and 9 years old."

Devine started teaching swimming lessons at the Wilkes-Barre YMCA while in high school. Throughout college, she coached a team with George Cosgrove at the YMCA. "I just dug out all my old workout books," she said. "I don't know why I saved them all these years."

Lake-Lehman started the swimming team for seventh through 12th graders this fall. The team uses the pool at College Misericordia for practice.

The nervousness is gone now. Most of them had no idea what a meet was even like," said Devine after the competition ended. "We know we have our work cut out for us, but I saw a major improvement in the three weeks since we started practicing."

The atmosphere was no surprise to Lehman assistant coach Dwayne Poepperling, who swam on teams at the atholic Youth Center, Meyers High chool and Sheppard College in West irginia.

### DALLAS SCHOOL BOARD **Usavage steps aside** as president, Bigus elected unanimously


DALLAS TWP. — The Dallas School Board unanimously replaced President David Usavage with Russell Bigus on Dec. 6.

Usavage said he had told the board that he did not want a second year in the top seat. As president he oversaw some of the most hotly debated changes in the district, including revised policies that gave more power to the board, a new business manger, new accountants and the early departure of Superintendent Gilbert Griffiths.

Usavage stressed he had not set out as president with any specific goals, but he felt satisfied with district progress and had "enjoyed" his stint on the job. He praised Bigus as "a very intelligent individual."

The board also elected Frank Natitus as vice president and Gary Mathers as assistant board secretary. Board member James Richardson was absent. The votes were unanimous, with nominees repeatedly abstaining from voting for themselves, even after Solicitor Ben Jones III pointed out they could legally do so.

The board also reappointed Usavage, Natitus and Mathers as representatives to the West Side Area Vocational Technical School Board and elected
