Dallas Class of '95 plans reunion

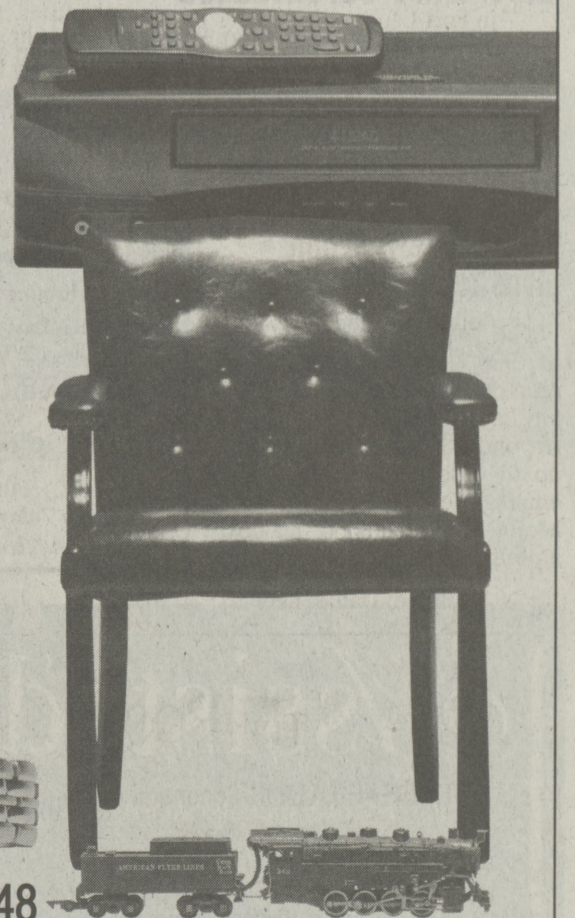
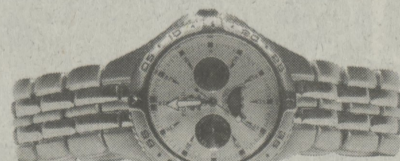
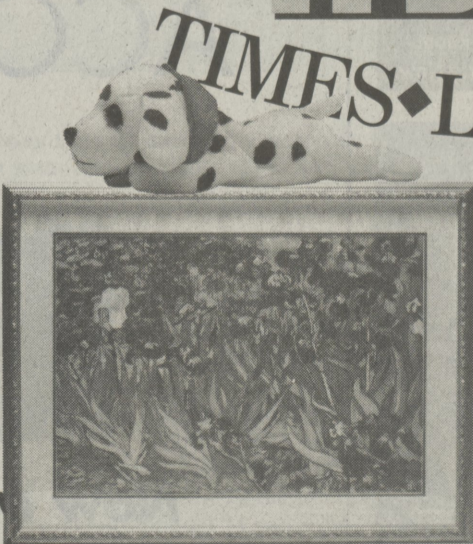
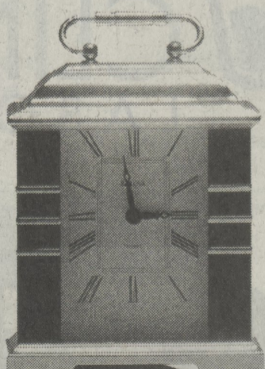
