Horwatt was assigned to Stead Air Force Base, Reno, NV, for the transition in a C-46 Curtiss Commando, which was the largest aircraft of its day. Later he was assigned to Karachi, India and transferred to the 1337th Base Unit at Sookerating. On July 31, 1945, he completed 100 round-trip missions as a pilot of a C-46 over the Himalayan Mountains (The Hump) between India and China bases, which resulted in 729 combat hours and 848 hours of flying in the CBI Theater. He was awarded the Distinguished Flying Cross, 2 Air Medals, Asiatic Pacific Medal with 3 Bronze Stars, Air Transport Command Scheduled Passenger first Pilot Rating, The American Campaign and Victory Medals and The Chinese Air Force Pilot Wings. While still in the Active Reserve, he graduated Wyoming Seminary Dean School of Business, class of 1947. With the outbreak of the Korean War, he was assigned to the Air Proving Ground Command in March of 1951 at Eglin Air Force Base in Florida. His duty was then with the Light Bomb Test Squadron of the 3200th Proof Test Group under the command of Paul W. Tibbetts, who was the pilot of the Enola Gay, which dropped the atomic bomb on Hiroshima. At that time, he performed testing and evaluation of various aircraft and sophisticated equipment over a 2-year period and left the military as a captain.

His business career included being auditor with the firm of Ralph Chase, CPA, Scranton; sales manager, Wesley Auto Sales, Nanticoke; and self employed as Horwatt Auto Sales, West Nanticoke; sales of Brantley Helicopters; and later as a long-time equipment leasing broker - specialist. In retirement, he worked with his son at Woolberts in the recreational boat business.
