



Mr. Ken Marquis, owner of Marquis Art and Frame, is sponsoring first, second, and third place prizes. Judging will take place after the March 10 deadline and prizes will be awarded at the event, which is scheduled to be held May 15 through May 18.

First prize is \$100, second prize is \$50, third prize is \$25, and there will be 10 honorable mention awards.

Color presentations are preferred but not required, with a three color maximum. No photographic materials may be used. No framed or matted tries will be accepted. No pend or colored pencils may be used. Crayon, ink, and marker are acceptable. Words and numbers may not be included.

Each student may enter no more than one piece of work.

The student should submit their work to a designated staff member of the Osterhout Public Library by March 10. Each entry should have the name of the student, grade, age, home phone number, school, and art or classroom teacher listed on the back of the entry. All entries become the property of the Fine Arts Fiesta and will not be returned.


