

Tom Melone, finance manager for the district, told the board the budgeting process for the 2014-2015 school year has begun. Melone said of the process, "We intend to follow last year's calendar of events."

Melone explained that a spending plan, which may include a tax increase, will be prepared in January.

According to Melone, last year's allowable percentage increase in millage was 2.2 and this year's is 2.1. A mill is a \$1 tax on each \$1,000 of assessed property value.

Superintendent James McGovern read a proposed mission statement, including the district's vision and beliefs. The mission statement will be up for adoption at January's meeting.
