GOLD vs. SILVER.

"If there is any one who believes the Gold Standard is a good thing, or that it must be maintained, I warn him not to cast his vote for me, because I promise him it will not be maintained in this country longer than I am able to get rid of it."

Mr. Bryan made a "promise" to the American voters that the Gold Standard law "will not be maintained in this country longer than I am (he is) able to get rid of it."

There are several strings to Mr. Bryan's nomination bow, but none of them will stand the November strain.

Owing to the backwardness of the country in responding to the Democratic appeals to start a fire in the rear of the American soldiers in the field, Mr. Bryan may have to do a little more parading before the end of the campaign.

The leading German-American citizens are vigorously resenting the Democratic notion that they are antagonistic to the government. The German voter is for stability in all things and at all times.

Chairman Jones insists that it is not the square thing to discuss his round cotton bale trust.

So far Mr. Bryan has had the greatest difficulty with those members of his audiences who insist upon him explaining his predictions of four years ago.

It is a mistake to assume that Mr. Bryan has not gained anything by his utterances on "imperialism." His reputation for trick politics has been added to materially.

The Democratic workers think that it is very pretty to receive pictures of Mr. Bryan oiling the farm wagon, but they would rather know just how Mr. Jones looks greasing the wagon.

The Democrats are staggering as usual under a multiplicity of issues that do not fit all parts of the country. They cannot talk free silver in the East, they dare not press anti-expansion in the West, they fear to dwell on free trade in the manufacturing districts, and the "consent of the governed" is an expression non grata in the South.

The pessimistic predictions of the prophet of calamity, so freely pronounced in 1896, have been disproven by the experiences of the past two years. His foresight was bad. This year his prophetic appeal to history for confirmation, but the facts of history show that his hindsight is no better than his foresight.

If there were really any danger of empire there would be no Democratic, Republican, Populist or Prohibition party. Tariff, silver, whisky and everything else would be forgotten and the entire nation would rise as one man and put it down.

The charge of militarism made by the Democratic candidate for Presidency is an insult to every American soldier serving under the flag. All soldiers, whether regulars, volunteers or in the militia, are volunteers. They have entered the service of their own free will and accord. None were drafted.

If free silver is dead Mr. Bryan should not dislike the Republican party for killing it, as he has been making lots of money exhibiting its corpse.

The ghost of imperialism is so transparent that even a near-sighted man can see it to 1 through its shadowy form.

If elected would Bryan call an extra session of Congress and urge the free and unlimited coinage of silver at the ratio of 16 to 1, without which he has repeatedly declared the country would go to ruin?

After all, crop conditions all over the country afford very little material for the calamity howlers.

Mr. Bryan should cede the sovereignty of his farm at Lincoln, Neb., to Spain or France. The land was acquired by the United States without the "consent of the governed" by another Democrat, Thomas Jefferson. How Mr. Bryan can consent to live in Nebraska, when this circumstance is considered, is unexplainable.
