Large and Best Sale of Jerseys in This Country for Years.  
The recent auction sale at Hood Farm, Lowell, Mass., dispersed 154 beautiful Jerseys to breeders and farmers all over the country from Maine to Oregon, it being the largest and most successful sale of American bred Jerseys that has been held in this country for years. There was an attendance of over 500, there being 85 different buyers, comprising the best known Jersey breeders in the country. The sale was conducted by Peter C. Kellogg of New York.  
The 48 cows sold brought \$9165, an average of \$190.67 heifers and calves sold for \$5890, and 39 bulls and bull calves brought \$2895.

A Michigan Lumber Camp Delicacy That Amused and Pleasured a Marrylander.  
"Although I am a Marylander, and an Eastern Shore one at that," said Chas. E. "We could do the same thing, and perhaps better, on the Eastern Shore, but we lack one thing. We haven't got the beavers to yield us their tails."

Not Sandwich Islands.  
The name formerly applied to the Hawaiian Group is now seldom used.  
The presence of a resolution adopted by the committee of geographers the other day, which recommended the name "Sandwich Islands" for the Hawaiian Islands, has probably more force of old habit or "slip of the pen." The name Sandwich islands is not properly applied today to any territory of Hawaii. Geographers and map makers all over the world have discontinued the use of the former name, says the New York Sun.  
The Hawaiian islands were called the Sandwich islands by the famous Capt. Cook, when he discovered them, in honor of a British nobleman who was one of the most conspicuous promoters of geographical discovery in his day. At the time the islands were named in his honor Lord Sandwich was lord of the admiralty. It was under his administration that Capt. Cook enriched geography with so many splendid and important discoveries. The naming of the islands for Lord Sandwich was referred to at the time as "a tribute justly due to the noble person for the liberal support these voyages have derived from his power."  
For many years the islands were known as the Sandwich Islands. When, however, the name became somewhat advanced in civilization they began to protest against the abolition of the name which they and their forefathers had known for many generations. They never used the name which Capt. Cook gave them. They called their country the Kingdom of Hawaii. In all their relations with other countries, in all their official papers, the name Sandwich never appeared. When King Kalakaua visited this country he was occasionally spoken of as "the king of the Sandwich Islands." He never failed to correct, most politely, the person who named him in this manner. The only reference to his little kingdom that ever seemed to distress him was when it was called the Sandwich Islands. Many missionaries and merchants sympathized with the desire of the natives to preserve their ancient names. For years past it has been regarded as improper for an explorer to attach a new name to any geographical object having a distinct native name. The British themselves have been great sticklers for the retention of native names except when some conspicuous object was named after members of the royal family. But the fact that the retention of native names is generally advocated helped to bring about the change of the name that Capt. Cook gave to the Hawaiian group.  
All the best atlases now give the native name to the group. The "International Geography" published in Great Britain, speaks of the Hawaiian Islands as "formerly known as the Sandwich Islands."  
Of course the islands can never be called the Sandwich Islands in our country, for this would be contrary to the present usage in all lands and to our own official designation of the new "territory of Hawaii."

NOT SANDWICH ISLANDS.

The presence of a resolution adopted by the committee of geographers the other day, which recommended the name "Sandwich Islands" for the Hawaiian Islands, has probably more force of old habit or "slip of the pen." The name Sandwich islands is not properly applied today to any territory of Hawaii. Geographers and map makers all over the world have discontinued the use of the former name, says the New York Sun.  
The Hawaiian islands were called the Sandwich islands by the famous Capt. Cook, when he discovered them, in honor of a British nobleman who was one of the most conspicuous promoters of geographical discovery in his day. At the time the islands were named in his honor Lord Sandwich was lord of the admiralty. It was under his administration that Capt. Cook enriched geography with so many splendid and important discoveries. The naming of the islands for Lord Sandwich was referred to at the time as "a tribute justly due to the noble person for the liberal support these voyages have derived from his power."  
For many years the islands were known as the Sandwich Islands. When, however, the name became somewhat advanced in civilization they began to protest against the abolition of the name which they and their forefathers had known for many generations. They never used the name which Capt. Cook gave them. They called their country the Kingdom of Hawaii. In all their relations with other countries, in all their official papers, the name Sandwich never appeared. When King Kalakaua visited this country he was occasionally spoken of as "the king of the Sandwich Islands." He never failed to correct, most politely, the person who named him in this manner. The only reference to his little kingdom that ever seemed to distress him was when it was called the Sandwich Islands. Many missionaries and merchants sympathized with the desire of the natives to preserve their ancient names. For years past it has been regarded as improper for an explorer to attach a new name to any geographical object having a distinct native name. The British themselves have been great sticklers for the retention of native names except when some conspicuous object was named after members of the royal family. But the fact that the retention of native names is generally advocated helped to bring about the change of the name that Capt. Cook gave to the Hawaiian group.  
All the best atlases now give the native name to the group. The "International Geography" published in Great Britain, speaks of the Hawaiian Islands as "formerly known as the Sandwich Islands."  
Of course the islands can never be called the Sandwich Islands in our country, for this would be contrary to the present usage in all lands and to our own official designation of the new "territory of Hawaii."
