Mr. Staples Elected

Hon. C. B. Staples was elected President Judge of this district Tuesday, defeating Hon. W. A. Erdman by a comparatively small majority.

The vote in Monroe was, Staples 2,282, Erdman 2,045, Staples majority, 237. In Pike Staples's majority was 411, making his majority in the district 648.

Mr. Staples lost his own town, Stroudsburg, which usually gives a democratic majority of over 150, by 321 adverse majority.

THE GIST OF THE BIBLE

(A course of lessons in Bible study conducted by Rev. V. A. Wood on Monday evenings at the Methodist Parsonage.)

LESSON IV

Drivator 1. In chapter 17, the established covenant of God with Abraham is reiterated when Abram is 99 years old. Circumcision is given as the seal of this promise. Abram's and Sarai's names are changed and a son is promised by Sarah though she is 90 years of age. Read chapters 18 and 19. In chapter 20 Abraham again practices culpable deception concerning his wife, and Sarah is taken by Abimelech, king of Gerar, but is restored to Abraham with many gifts upon God's timely intercession. Read chapter 21. Note chief events in chapters read. Who were the travelers entertained by Abraham? What fate overhung Sodom? Was it right for Lot to live in the midst of so wicked a city? What fate overtook Lot's wife, and why? Was Hagar treated justly?

Division 2. Read John 2, 3 and 4. Chief events. First Miracle, 2: 1-11; Jesus Cleanses the Temple v 13-23; Nicodemus and Jesus, 3: 1-21; John's last Testimony, 4: 25-36; Visit to Samaria, 4: 1-42; Healing Nobleman's Son, v 46-54. These chapters portray Christ's first appearance at Cana, Capernaum and Jerusalem. He made a good impression but earthly defeat awaited him. Why? (See John 18: 36) Did Jesus make intoxicating wine? What was "good" wine? Has the cleansing of the temple any bearing on "Church fairs"? Can a person be secretly a Christian? (Luke 12: 8, 9, Rom. 10: 10.) In the light of John 3: 30 and Matt. 24: 10 would you consider John's life a failure? Did the Samaritans confess Jesus? (4: 42.) When was the nobleman's son healed?

Division 3. Read Romans 7 and 8. Chapter 7: War between the true and the corrupt self. Does the struggle take place in the life of a truly saved person? Is there a higher plane of experience? Can anyone succeed in keeping the whole law? In what sense and for what purpose are we "delivered from the law"? v 6. Discuss meaning of v 25. Chapter 8: Completeness in Christ. Verses for study: 6, 10, 26, 29-30, "Quicken your mortal bodies" v 11, "joint heirs with Christ" v 17, "manifestation" v 19, "bondage of corruption" v 21, "redemption of our body" v 33, "God's elect" v 33. Is studying v 29, 30 remember that foreknowledge does not bring an event to pass. God foreknows the saved and the lost, but men determine their own fate. Note enemies to our love of Christ and of God's love toward us, v 35-39.
