THE DEATH PENALTY IN EUROPE.

"Barbaric" Russia was the first to abolish Capital Punishment.

The revival of the guillotine in France, the most enlightened of all European countries, recalls the fact that "barbaric" Russia, of all governments in the world, was the first to abolish the death penalty.

The great Catharine was moved to this step by reading Beccaria's celebrated work, "Criminals and Punishments." Ever since the appearance of that book Russia punishes even the vilest of crimes with imprisonment and banishment only. Her bullets and ropes are exclusively for political offenders or suspects.

Catherine's example was followed, in 1789, by a petty Italian prince. A year later Emperor Joseph II. abolished the death penalty, in Austria. It was, however, re-established in 1795 by Francis II. in consequence of the French Revolution.

In 1848 the German Revolutionary Government did away with the death penalty, and France followed suit. The German rulers, when they got the upper hand again, promptly re-established capital punishment, and so did France, ten years later, after Orsini's attempt upon Napoleon III.

Russia, then, remains the only great Power of Europe whose criminal code does not recognize the death penalty.

The others are: The Republic of San Marino since 1848; Roumania, since 1859, and Switzerland, since 1874. However, the central government of Switzerland, in 1855, empowered the different cantons to re-establish the death penalty if public opinion demanded it. Since then eight cantons have done so.

Not a single execution has taken place in Belgium since 1863, though the law permits executions. The new criminal code of Norway makes no mention of the death penalty, and it is therefore considered abolished. Neither does the Prince of Monaco permit execution in his tiny territory, for which reason the Goths, man and wife, escaped the death penalty in the recent Thoral Monte Carlo murder and robbery case.
