In consequence of sickness, our carrier boy did not get around with his address on New-Year's day, but will wait on the Borough patrons this afternoon.

THE PATRIOTIC CIRCLE: At a meeting of 'The Circle,' held on the evening of the 19th ultimo, the following officers were elected to serve the ensuing year: President, Mrs. George M. Clawges, Vice President, Mrs. James Cushman, Treasurer, Mrs. F. L. Baker, Secretary, Miss Emma Radisill. Executive Committee, Mrs. S. Doyle, Chairman, Mm'd Spangler, Rowe, Erisman, Appold, McMichael, Misses Haines and Hopkins.

This society organized December 12th 1861, and has, during the past year, purchased 834 yards of cloth, which has been made up into clothing for the sick and wounded soldiers. Nine boxes of these articles have been sent to the various hospitals; four to Georgetown, two to Harrisburg, two to St. Louis and one to York, Pa.

The expenditures of the society for material and freight during the year, have amounted to \$304.66, all of which has been paid out of the treasury of the society.

It now remains with the public to decide whether 'The Circle' shall continue in this good work. For the liberal encouragement already received, the ladies are thankful, and are willing—aye, anxious—to go on, but the funds are nearly exhausted, and they cannot proceed in their labors without means. They trust this appeal will not be in vain at a time when the sufferings of our fellow beings call so loudly for sympathy and aid.

Rev.
