

In addition to his active involvement with the Palmyra Brethren In Christ Church where he is a member and serves as a deacon, Dr. Hoffman functions on the governing bodies of a number of organizations. He also sits on the Palmyra Borough Board of Health, was medical directors of the United Christian Church Home near Annville, PA and served as board member of the Brooklane Psychiatric Center, Hagerstown, MD.
