## ORDINANCE NO. 390

AN ORDINANCE AMENDING ORDINANCE NO. 334, ENACTED JUNE 8, 1970, AS AMENDED REDUCING THE SPEED LIMIT ON MARIETTA AVENUE AND PROHIBITING PARKING IN CERTAIN LOCATIONS WITH-IN THE BOROUGH OF MOUNT JOY.

BE IT ORDAINED AND ENACTED by Borough Council of the Borough of Mount Joy, Lancaster County, Pennsylvania, and it is hereby ordained and enacted as follows:

Section 1. Section 2 of Article II of Ordinance No. 334, enacted June 8, 1970, as amended, is hereby amended as follows:

Street	Between	Speed Limit
6. Marietta Avenue		25 M.P.H.

Section 2. Section 4 of Article III of Ordinance No. 334, enacted June 8, 1970, as amended is hereby amended by adding the following locations where parking shall be prohibited at all times:

Street	Side	Between
16. Marietta Avenue	North	50 feet west of South Market Street
17. Manheim Street	South	Barbara Street and North Market Street
18. East Main Street (Rt. 230)	South	25 feet west of First Federal Savings & Loan Driveway
19. Donegal Springs Road (LR 36002)	North	South Angle Street and Musser Road

Section 3. In all other respects Ordinance No. 334 enacted June 8, 1970, as amended, shall remain the same.

Section 4. Effective Date. This Ordinance shall become effective on August 8, 1977.
