#### Head Start drive begins

The Lancaster County Child Development Program (Head Start) is starting its recruitment drive for the 1977-78 year, which begins in September.

Pre-school children of low or moderate income families who need day care to retain employment of at least twenty hours per week, or to be enrolled in job training are given highest priority in enrollment. Children of parents attending high school, day-time GED program, or college will also be considered for enrollment as space permits.

Children must be at least three years old at the time of enrollment. If the children are old enough for kindergarten, they are not eligible for the program.

To be eligible for Day Care services, the family's income cannot exceed certain amounts, which depends on the family size. For example, a family of four can earn about \$1,000 per month.

There are centers in Mount Joy and Columbia.

The centers operate five days a week throughout the year.

For more information, or to apply for Day Care, the parent should contact the Lancaster County Development Program (Head Start) at 299-7301, extension 50. The administrative office is located at 630 Rockland Street, Lancaster.



# **Survey** results

Senator Ralph W. Hess, R-28 District, announced the results of his first 30-day district wide survey (York-Lancaster). The questionnaire was developed to reflect the current legislative calendar, so that the Senator would have constituent imput on the current issues. The 5 questions were:

1. Would you support a proposal to call a U.S. Constitutional Convention in order to amend the Constitution to prohibit any and all abortions from the moment of fertilization? The answers were: Yes (30.0%); No (67.4%); Undecided (2.6%).

2. Do you favor granting a sales tax exemption on the purchase of energy saving devices such as insulation and solar heating? The answers were: Yes (83.1%); No (16.4%); Un. (0.5%).

3. Do you support any action to bail out the Philadelphia Public Schools with State funds? The answers were: Yes (13.1%); No (84.9%); Un. (2.0%).

4. Would you favor the continued use of studded tired even if their use costs the State \$50 million a year in added highway repairs and would result in a 1c a gallon gas tax increase? The answers were: Yes (16.4%); No (82.8%); Un. (0.8%).

5. Do you favor lowering the drinking age to 20 (2.6%), 19 (8.7%), 18 (9.0%), or not at all (78.4%), undecided (1.3%).

This was a random survey, telephone questions, with discussion and responses solicited.

This will be a continuous survey based on the pending legislation. Each survey period will be 30 days, with results announced 10 days after the close of each period.
