Taxes to skyrocket

Happy April Fool's Day to all taxpayers! —ed.

East Donegal Township will be required to spend approximately \$5.7 million over the next few years to eliminate violence-causing chemicals in the water supply, according to government spokespersons for the U.S.C.O.C.C.V.

Victor D. Feate, under-assistant South-Central Eastern Seaboard chief of Auxiliary Operations in Charge of Purity of Supply of the United States Commission on Chemically Caused Violence (U.S.C.O.C.C.V.) happened to be driving along Rte. 141. Feate later stated in his report that "a rusted, apparently non-complying muffled 1959 model Chevrolet sedan, with the rear axle raised, driven by a white male aged approximately 18 years, passed

my U.S.C.O.C.C.V. car, blowing its horn. This was an Incipient Violence Warning according to the handbook (section 666, paragraph 13, sentence 69), and, in keeping with official procedures, a Violence-Producing Chemical Test was ordered."

Federal Inspectors showed up promptly and determined, after costly laboratory analysis of East Donegal water, soil, air, and empty beer cans samples, that a substance known only as "d-extase-nn-diethyltriptamine 13 potentate" existed in the empty beer cans in a proportion of 1.342 parts per Million (PPM). Since 1.341 PPM constitute a level tending to cause violent behavior in young persons exposed to the chemical,

the U.S.C.O.C.C.V. has set October 31st, 1978, as the deadline for reducing the concentration to 1.341 PPM. However, this will be very costly.

East Donegal would have been eligible for funding in combating the chemical menace, but, unfortunately, it lies within the Special Jurisdiction Area of the U.S.C.C.V.C., or United States Chemically Caused Violence Committee. Since the problem was discovered by the U.S.C.O.C.C.V., which is a branch of the S.P.Q.R. the U.S.C.C.V.C. (a branch of P.D.Q.) cannot, under the guidelines and Carter's Zero Base Budgeting Program, pay any of the \$5.7 million clean-up bill.
