AN ORDINANCE REPEAL-ING CERTAIN ORDIN-ANCES PREVIOUSLY EN-ACTED BY THE BOR-**OUGH OF MOUNT JOY.**

**ORDINANCE NO.397** 

AN ORDINANCE PRE-DISCOUNT **SCRIBING** AND PENALTY RATES APPLICABLE TO REAL ESTATE AND PER CAP-ITA TAXES LEVIED BY THE BOROUGH OF MOUNT JOY.

BE IT ORDAINED AND ENACTED by the Borough Council of the Borough of Mount Joy, Lancaster County, Pennsylvania, and it is hereby ordained and enacted as follows:

Section 1. A discount of two per cent (2%) of the amount of the real estate tax and the per capita tax levied by the Borough of Mount Joy in any year shall be allowed on the full amount of the tax for that year if paid by a taxpayer before May 1 of that year. Those taxes shall be payable at their net amount between May 1 and June 30. On and after July 1 of every year, a penalty of ten per cent (10%) shall be added to any such tax not paid for that year.

Section 2. This ordinance shall become effective immediately.
