## ORDINANCE NO. 399

**AN ORDINANCE PROHIBITING CERTAIN ACTIVITIES UPON STREETS, ALLEYS, AND ROAD-**

**WAYS WITHIN THE BOROUGH OF MOUNT JOY.**

BE IT ORDAINED AND ENACTED by the Borough Council of the Borough of Mount Joy, Lancaster County, Pennsylvania, and it is hereby ordained and enacted as follows:

**Section 1.** It shall be unlawful for any person to repair any motor vehicle or other vehicle while that vehicle is standing on any street, alley or roadway in the Borough of Mount Joy, except that the following repairs or types of repairs shall be permitted:

a. Emergency repairs necessary to prevent the obstruction of traffic;

b. Emergency repairs necessary to permit the removal of a vehicle from a street, alley, or roadway; and

c. Minor repairs such as tire changes.

**Section 2.** Any person who shall violate any provision of this ordinance shall, upon conviction, be sentenced to pay a fine of not more than twenty-five dollars (\$25.00) and costs of prosecution, or in default of payment of the fine and costs, to undergo imprisonment for not more than ten (10) days. Each and every day that said violation shall continue shall constitute a separate offense under this ordinance.

**Section 3.** This ordinance shall become effective immediately.

Mr. and Mrs. Perrick also attended.

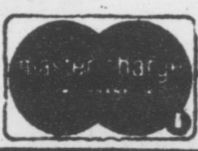

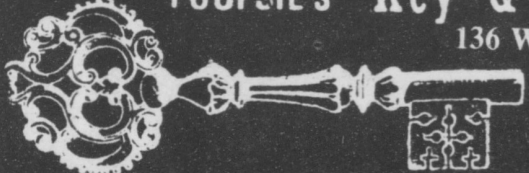
