For the year 1979, Maytown Fire Company members and equipment responded on 91 emergency calls, 18 Public Service calls, 13 immediate Pump and Work Details, and 3 Controlled Burnings for a total of 125 calls.

Breakdown of emergency calls is as follows: 2 Smoke Investigations; 19 Assist Calls; 1 Search Party; 28 Vehicle Accidents; 13 Tree, Grass or Brush fires; 4 Structure Fires; 8 Automobile Fire Alarms; 5 Car or Truck Fires; 2 Standbys for T.M.I.; 1 False Alarm; 2 Dumpster Fires; 1 Electric Lines on fire; and 5 Standbys for neighboring Fire Companies.

Property damage for the area of East Donegal Township covered by Maytown Fire Company is estimated at \$16,750.00. Property saved for the Township was estimated at \$78,700.00.

Total fire equipment was in service 152 hours and traveled 1524 miles. A total of 816 Firepeople and 115 Fire Police responded to assist the year's calls, logging approximately 1389 hours of service.

-Although the year 1979 showed a sharp increase in the number of emergency calls for the Fire Company, Chief Shaffner commended the residents of Maytown and East Donegal Township for their awareness of fire safety resulting in a substantial decrease in property damage from the 1978 damage estimate of \$136,000.00.

There were no injurys or deaths resulting from fires for the year.
