## Maytown Fire Co. reports

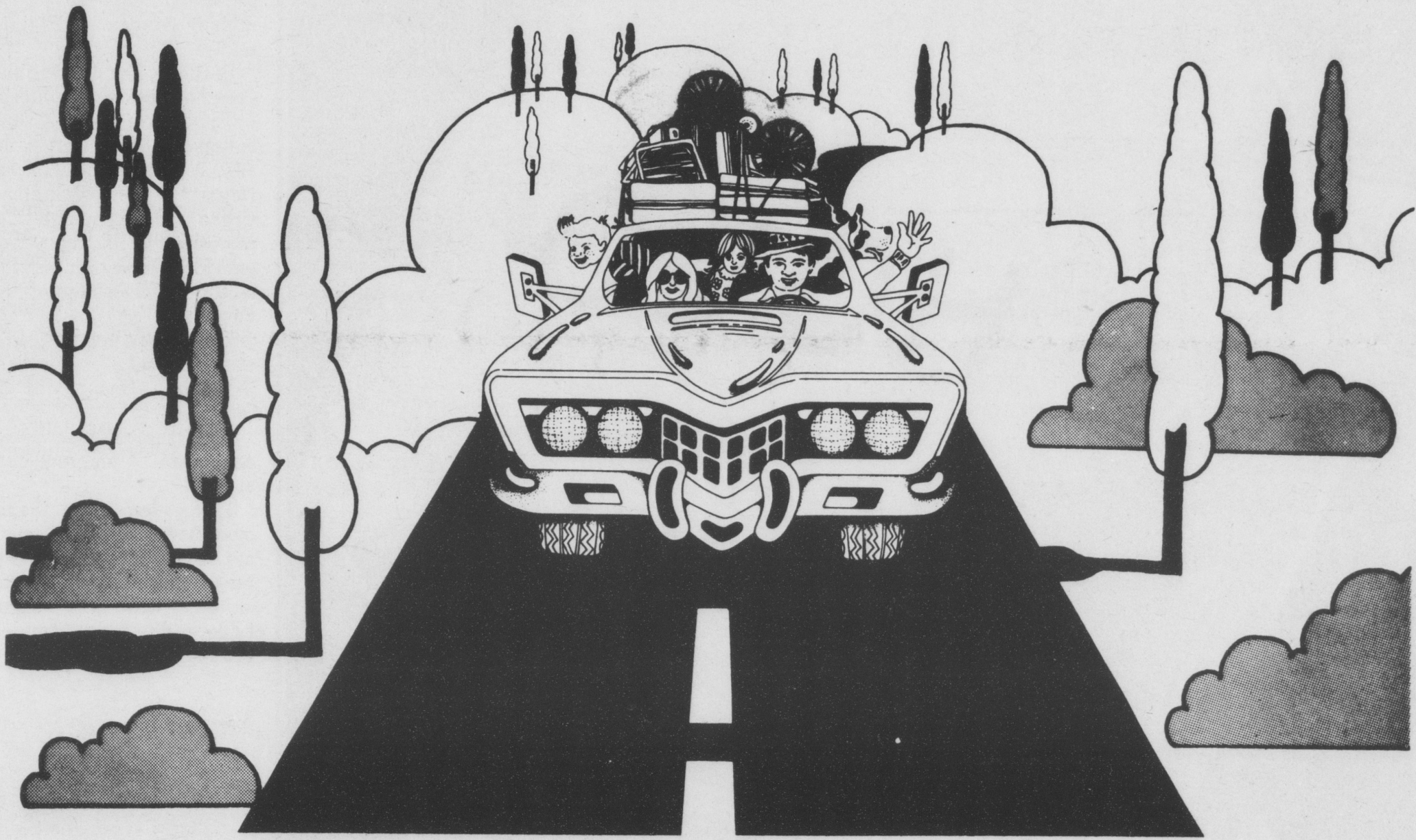
The Maytown-East Donegal Fire Company responded to seven emergency calls during the month of May, according to Fire Chief Charles Shaffner. Shaffner reported that the company also responded to eight work details, one public service call and one controlled burning. Fire Company equipment was in service 29 hours and a total of 149 firemen assisted with all of the calls.

Emergency calls consisted of the following: one truck fire; one assist to Marietta Fire Company at a structure fire; two vehicle accidents; one reported structure fire, false alarm with no need of Fire Company services; one brush fire; and one car fire.

Property damage for the month was estimated at \$350.00. Endangered property saved was estimated at \$9,300.00.

The next monthly meeting of the Fire Company is scheduled for Monday, July 14, at 7:00 pm.

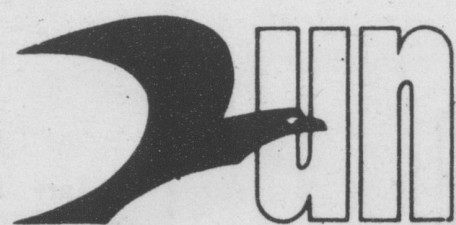
