

Seven Mount Joy residents recently completed requirements for Red Cross certification in CPR. The course was conducted by Tim and Jessie Crouser under the sponsorship of the Mount Joy Jaycees. CPR stands for cardiopulmonary resuscitation, a method by which the layman may sustain life in a choking or heart-attack victim until regular emergency medical help arrives. The course includes hands-on practice on manikins.

Mount Joy's program was recently awarded third place in the state by Pennsylvania Jaycees. The local Jaycee chapter has one of the few Jaycee-run projects in the county open to residents in the community.



Lemon Street between Main Street and Pink Alley was abandoned, also an unnamed alley running northerly from Donegal Springs Road.

A bid from Booth Laboratories of Harrisburg to supply an intoxilizer to the police department for \$4300 was approved, subject to approval by the State which is funding the purchase.

Holders of the lease of the



borough property adjacent to the Municipal Building will be notified of termination of the lease this fall, prior to improvements in the property.

The borough will contribute \$1500 to the Northwest Lancaster County Paramedic Unit in 1981, to help in the education of Mount Joy's ambulance crews.

Officer Aument addressed Council on the urgent need of the police department for a new pen for stray dogs. The present pen is constantly being broken into. Officer Aument suggested that a garage behind the Municipal Building be used to house the dogs.

"Keep Marietta Clean" posters; consideration of ways the borough might control distribution of free newspapers that blow around streets; clean-up projects by local organizations such as Scouts.

Loitering: Enforcement of any local laws that apply to specific cases; enforcement of local curfew which states that all those under 18 years of age should be off the streets by 10 pm week nights and midnight Friday and Saturday nights.

Dog Problem: enforcement of license and leash requirements; enforcement of cruelty to animals laws; asking Marietta landlords to be stringent in their requirements of tenants in regard to dogs; consider enactment of a "pooperscooper" ordinance for downtown Marietta.

Public Use of Drugs and Alcohol: citizens be willing to report such acts to the police and be willing to testify to such acts; police arrests of violators of ordinances on public use of drugs and alcohol; police prosecute offenders to the fullest extent of the law.

Vandalism: urge the local courts to require that offenders make restitution and repair damages themselves as a deterrent to further such vandalism, a locally implemented program in the school system to encourage youths to take part in the renovation of buildings, both public and private; enforce parking ordinances and give serious thought to present parkingmeter problems.

Housing: enforce housing and occupancy codes in order to regulate the number of occupants in apartments to prevent apartment use as "party houses;" make efforts to locate new business in downtown Marietta's business district; regulate the number of new apartments allowed in the business district.

Miscellaneous: Council revise standards in regard to business signs so as to make them more compatible with the nature of the town; encourage programs for the young people in Marietta, e.g. Big Brothers, Big Sisters, to help them relate to the community, discuss problems, etc.; create an employment pool directed towards young people to make connections with local employers and residents requiring temporary, parttime or full-time help; consider a meeting with East Donegal Township regarding the development of Route 441 around Marietta, to keep such development compatible with the community.
