A AMENDMENT TO THE CONSTITUTION PROPOSED BY THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE COMMONWEALTH OF PENNSYLVANIA.

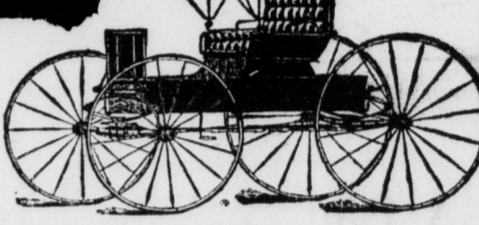
