#### MOUNT JOY HAS ONLY BON-DED TOBACCO WAREHOUSE IN THE STATE OF PENN-SYLVANIA.

Co-operation was the impulse which yesterday afternoon brought more than two hundred farmers and tobacco growers of Lancaster county to the hall here .-

**Co-operation** was the thought which prevaded the meeting during more than two hours of speech making and questioning on the part of the audience.

Co-operation was the topic upon which representatives of the United States bureau of markets, the Pennsylvania bureau of markets, the bank-ing interests and the local farm bureau addressed the tobacco men.

A Co-operative body, in the opin-ion of P. R. Taylor, chief of the Pennsylvania bureau of markets, must have three honest reasons for its existence.

They are: (1), a definite job to perform for the community in which they exist; (2), available capital to finance the crop and the business which they undertake to 1912. handle; and (3)' loyalty and relation of the members to the cooperative management.

The Mount Joy Farm Bureau company under whose direction the co-operative meeting was held, seemed to have these three fundamentals for doing a real job for the farmers in whom they claim to be interested.

Franklin B. Wilkenson, of the United States bureau of markets, explained the significance of a Federal bonded warehouse and remarked that the one at Mount Joy is the only one of its kind in the state of Pennsylvania.

The federal license is significant of the fact that a bond has been filed for the protection of any one dealing at that warehouse. The grower can collect from the bonding company for any damages resulting to the crop while it is in storage

The Mount Joy Farm Products company was presented as a company which is co-operative and working under the United States warehouse act.

Three Classes of Farmers P. R. R. Taylor. chief of the Pennsylvania Bureau, divided farmers into three classes. They are :-

(1) Those which are satisfied with the prices they are getting for the products and the conditions govern ing the markets.

(2) Those who are not satisfied with the conditions and the prices but who prefer to blame some other person than themselves for both the prices and the conditions of the market.

(3) Those who believe that they should do at least half of the job.
