Mount Joy Borough School Per Capita Tax
The School District of the Borough of Mount Joy gives notice that its School Board intends to adopt a resolution on June 11, 1953 (at 6:00 p. m. standard time, at Mount Joy Grade School building), levying a per capita tax of \$5 for the school year 1953-54 on each adult resident of said School District, under the provisions of the Act of 1947, P. M. EDSP, amended, in addition to the \$5 per capita tax authorized under the Public School Code of 1949. Imposition of this additional tax (from which it is estimated that \$8,400 annual revenue will be derived) is necessitated because of increased school costs; because the per capita tax authorized under the Public School Code is limited to \$5; and because it would be inequitable to property owners to collect the entire amount of said increased costs in the form of increased real estate taxes.

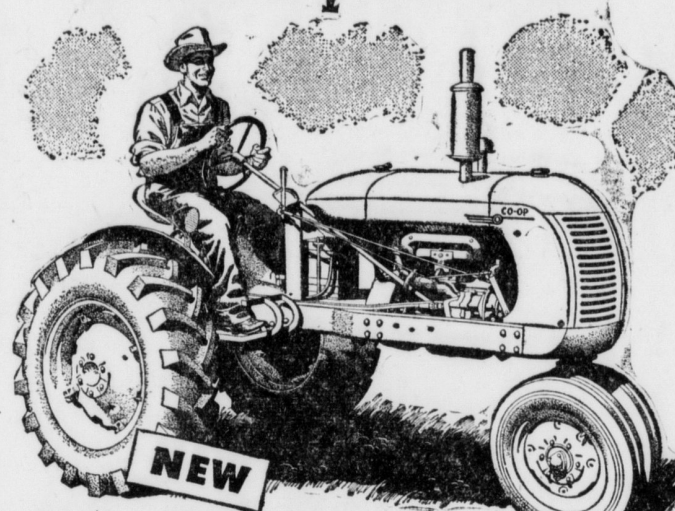

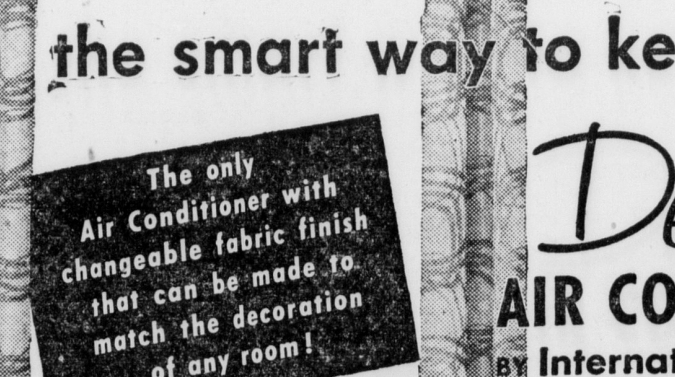
