To Offer Exam For Postmaster

An examination for Postmaster at Landisville at a salary of \$4530 a year, will be open for receipt of applications until Jan. 2, the U. S. Civil Commission has announced.

The Commission is taking all possible steps through special publicity to civic and other community organizations to encourage well qualified persons to apply for the examination.

Competitors for the postmaster vacancy must have at least 1 year of experience showing that they have the ability to conduct and manage the community's postal business efficiently and to supervise employees so that customers are satisfied with the service.

Competitors must show that they can deal with the public agreeably and effectively and that they are reliable citizens who would command the respect and confidence of patrons of the post office.

Applicants must take a written test. Those who pass will be assigned final ratings on the basis of this test and on their experience, ability, and character. There is a 1-year residence requirement and applicants must have reached their 18th birthday on the closing date for receipt of applications. Persons over 70 years of age may not be appointed.

Complete information about the examination requirements and instructions for filing applications may be obtained at the post office for which the examination is being announced. Application forms must be filed with the U. S. Civil Service Commission, Washington 25 D. C., and must be received or post-marked not later than the closing date.

ENDS RECRUIT TRAINING
Everett S. Wiseman, Jr., son of Mr. and Mrs. Everett S. Wiseman of Route 1, Mt. Joy, completed recruit training Nov. 30 at the Marine Corps Recruit Depot, Parris Island, S. C.

The 12-week training schedule included drill, bayonet training, physical conditioning, parades and ceremonies, and other military subjects.

Three weeks were spent on the rifle range where the recruits fired the M-1 rifle and received instruction in basic Marine infantry weapons.

"Kings and rulers who do not recognize their obligation to be obedient to laws higher than their own are morally sick and will, in turn, cause their sickness to spread over their nations," said a recent issue of Friend Journal.

"When the bridges to eternity are torn down, disorder, revolution, and war will ensue. We must be able to sense in all human law an orientation to a world beyond the present moment. Ruling powers must, therefore, be symbols of a higher authority, whether they be kings, presidents, or parliamentarians. And in their own realm they will necessarily practice restrictions and observe duties in the exercise of their power."

This, I think, is very well put. And even a cursory study of history will prove its soundness. A good government protects the liberty God bequeaths. A bad government usurps that liberty. A good government recognizes itself as simply a servant of God—preserving "the bridges to eternity" and thus fostering righteousness and peace. A bad government tends to ignore God—to tear down "the bridges to eternity" and thus to foster conflict. For, "when the bridges to eternity are torn down, disorder, revolution, and war will ensue." It has always been so—and, no doubt, always will be.
