ordinance, the owner, general agent, or contractor of a building or premises where such violation has been committed or shall exist, and the lessee or tenant of an entire building or entire premises where such violation has been committed or shall exist, the owner, general agent, contractor, lessee or tenant of any part of a building or premises in which part such violation has been committed or shall exist, and the general agent, architect, building contractor or any other person who knowingly commits, takes part or assists in any such violation or who maintains any building or premises in which any such violation shall exist, shall be liable on conviction thereof to a fine or penalty not exceeding \$25. for each and every offense, which shall inure to the benefit and use of the Township with the costs of suit, and, in default of payment thereof, the Justice of the Peace may, in his discretion, commit the offender to prison in the county jail for a period not exceeding thirty days for each and every of-fense. The zoning administrative officer shall give official written notice to the violator by registered mail that he is committing a violation. Each day's continuance of such violation after notification shall constitute a separate offense punishable by a like fine or penalty. Such fines hall be collected as like fines are now collected by law.


