> It might be well to stress again that revision of the present draft law could not be accomplished at least until the hostilities in Vietnam are ended. Our present efforts in Southeast Asia direct that our manpowe procurement remain basically unchanged. Also, it should be stressed that any draft revision is not a sign of giving in to the demands of misguided youths. Their behavior presently is deplorable and in many cases illegal. Whether or not they are to be punished by the courts or the draft is yet to be determined. There is no doubt that these youths should be properly penalized for their actions. However, their display of disrespect should not prevent us from making a meaningful study toward the possible future elimination of the Selective Service. The end result of such a study could be a valuable contribution to the armed forces and the nation as a whole.
