A representative from the Social Security Office in Lancaster will be there to talk on Medicare and other subjects and to answer any questions you may care to ask him.



#### COUNTY COMMISSIONERS **TO HOLD** PUBLIC HEARINGS



The Plan covers the main areas of population, land use, transportation, community facilities, housing, economy, utilities and services, environment, and human services. For each of these areas, the Plan includes background information and a series of proposals; it also points out the the proposals whose implementation should receive the highest priority and discusses the financial aspects of the implementation process.

Rep. Kenneth E. Brandt, R-Lancaster, announced that he will begin bringing his new "Mobile Office" to his 98th District consitutents to help solve their problems on a personal basis.

Using a converted camper for this month-long trial period, the State Assemblyman will kick off his effort at the steps of the Capitol building in Harrisburg and is scheduled to conduct a "drive-through" of all centrally located boroughs in the District.

"I am initiating this "mobile office" concept after numerous requests and careful evaluation toward improving service to the people," Brandt said.

"At the end of the month, the program will be reviewed to determine if the Mobile Office is the best method for reaching as many Lancaster Countians as possible with the least inconvenience to them.

"After leaving Harrisburg the first day, April 4, I plan to make a tour through the

the boroughs of Columbia, Elizabethtown, Manheim, Marietta, Mount Joy and Mountville on the same date," Brandt explained.

Brandt said his Mobile Office will be stationed at a different borough each Friday evening and Saturday morning throughout the month.

The exact times and locations for the rest of the month will be announced at a later date.
