1. James and Linda Spickler, R. D. #1, Mount Joy, Pa. to build an addition to present home for a beauty salon. The property is located along Carmany Road.

2. D. C. Gohn Associates, Inc., 24 East Main St., Mount Joy, Pa., Consulting Engineer for William M. Hess of Penn Realty, property located north side of Kraybill's Church Rd. (T-316) at Kraybill's Mennonite School. This exception is for relief of the 30-foot minimum building setback requirement affecting Lots 9 through 13 of Block "A" in Hessmar Manor due to an error by the previous surveyor regarding the omission

of 50-feet of the existing right-of-way of the Pennsylvania Power & Light Company overhead transmission line. It is requested that this minimum setback be revised and reduced to 22-feet since Lots 6 and 7 of Block "B" have been sold. The alternative of shifting Sellar Drive to the south is very impractical due to previous sale of lots.
