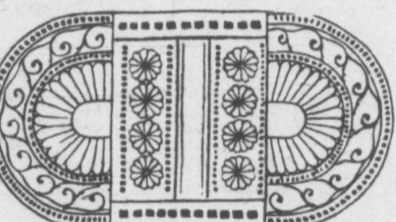

The Pennsylvania Department of Transportation is proposing revisions to the PennDOT Action Plan. The revisions reflect changes in Federal requirements as well as other changes.
