The Pianos. Evenings.—Faynor Brown of Florida, has made a very considerable exploration of the Everglades; the opinion he has arrived at and considerably entertains us. The soil is not good, but if it could be affected, the deposites laid bare would be found to be a purely vegetable decomposition, and as valuable as peat. The Everglades is intersected with numerous channels of water and streams, and the soil is composed of the mud and tannins of a depth of 10 feet.
